Resolution No. 020-2024**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC received from the Administrative Division a request for the procurement of Supply of Purified Drinking Water to PMO for CY 2024 through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (Php100,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-02 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1) Newark Spring Water Corp;
- 2) Crystal Blessed Purified Drinking Water Inc;
- 3) Global Quality Waters and Environmental Solutions Technologies Inc., and,
- 4) Crystal Purified Water Refilling Station

WHEREAS, after the deadline for submission and receipt of quotations, the PMO-BAC received two (2) quotations on 31 January 2024 and the Technical Working Group (TWG), conducted a thorough evaluation of the quotations received, the results are as follows:

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:


- a) declare the price quotation of **Newark Spring Water Corp.** as the *Lowest Calculated and Responsive Quotation (LCRQ)*; and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Supply of Purified Drinking Water to PMO for CY 2024 with Solicitation No. PMO-24-02 to **Newark Spring Water Corp.** at a

contract price of **Ninety-One Thousand Four Hundred Ninety-Seven Pesos and 60/100 (Php91,497.60)**.
