Supplemental/Bid Bulletin No. 1

This Supplemental/Bid Bulletin No. 1 is being issued to clarify certain provisions in the Bidding Documents, as follows:

PROSPECTIVE BIDDERS' CLARIFICATIONS	PMO-BAC RESPONSE
In Single Largest Completed Contracts (SLCC) if we bid on one lot only, what would be the SLCC? Is this for the whole contract or per lot?	Since the award is per lot, the SLCC is 50% of ABC per lot.
What reference number will be used if suppose we are to bid for only one lot, since you said this project with three lots is identified as PMO-01-2024?	You may label your bid as PMO-01-2024-A for Lot 1, PMO-01-2024-B for Lot 2, and PMO-01-2024-C for Lot 3. This was stated in the Invitation to Bid where each lot was clearly identified.
Do we need to prepare 3 Bid Security if we will submit bid for 3 lots?	Yes.
If we submit bids for the 3 lots, do we need to submit separate eligibility and technical documents for each lot?	We require the submission of one (1) Technical envelope. If you opt to submit bids for Lots 1, 2 & 3 you need to sign the corresponding documents for each lot.
For the list of all ongoing government and private contracts, do we need to attach supporting documents?	No. The supporting documents will be presented during post-qualification.
Are you going to provide templates for the Financial Proposal?	Yes, you can download the excel file of the Price Schedules (Form 7) from the PMO website at www.pmo.gov.ph
Regarding the agency fees, do you use DOLE rate or PADPAO rate?	The ABC for this procurement project was computed based on 24% agency fee.
Is there a deadline for the site inspection?	You can inspect the area until the deadline for submission of bids. And you can request a gate pass for the site inspection.
Is the site inspections mandatory?	No, site inspection is not mandatory.

Do we still need to password-protect the USB drive?	No, considering that the USB will be included in a sealed bid envelope, the password will not be needed.
	Documents under 1.7 and 1.8 of Annex A, Detailed Specifications are required at the point of submission of bids.
