

**Privatization and Management Office
Bids and Awards Committee (PMO-BAC)
Resolution No. 143-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC received a request from the Administrative Division for the conduct of Early Procurement Activity for the Provision of Outsourced Personnel Services for C.Y. 2024 with an Approved Budget for the Contract (ABC) of Ten Million One Hundred Thousand Pesos (PhP10,100,000.00), to be funded through the General Appropriations Act FY 2024 and its Corporate Fund FY 2024;

WHEREAS, GPPB Circular 06-2019 provides that Early Procurement Activity (EPA) shall be conducted from posting of the procurement opportunity, if required, until recommendation of the Bids and Awards Committee (BAC) to the Head of the Procuring Entity (HoPE) as to the award of the contract, pending approval of the funding source;

WHEREAS, the PMO-BAC posted an Invitation to Bid for the Provision of Outsourced Personnel for C.Y. 2024 with Solicitation No. PMO-02-2024 from 27 October 2023 to 14 December 2023 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO website, as well as in conspicuous places in its premises, in accordance with Section 21.2 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 (“The Government Procurement Reform Act”);

WHEREAS, during the Pre-Bid Conference on 10 November 2023 at 10:00 A.M. conducted at the 4th Floor Activity Area, PMO Building, only Mr. Erick Tolentino, authorized representative of DBP Service Corporation (DBPSC), attended;

WHEREAS, in response to the Invitation to Bid, only the DBPSC purchased the bidding documents and submitted its bid to the PMO-BAC, through its Secretariat, on 14 December 2023 at 9:22 A.M.;

WHEREAS, on 14 December 2023 at 10:00 A.M., the PMO-BAC together with its Technical Working Group (TWG), opened the bid submitted by DBPSC and conducted a preliminary evaluation of the technical and financial components using non-discretionary “PASS/FAIL” criteria, at the 4th Floor Activity Area, PMO Building;

WHEREAS, the PMO-BAC declared DBPSC as “PASSED” and instructed the TWG to conduct detailed evaluation of DBPSC’s financial proposal;

WHEREAS, on 14 December 2023 at 02:00 P.M., the TWG conducted detailed evaluation of DBPSC’s technical and financial proposal and recommended to the PMO-BAC to declare the bid of DBPSC as evaluated, in the amount of Nine Million Nine Hundred Forty Thousand Four Hundred Eighty-Four Pesos and 4/100 (PhP9,940,484.04), as the Single Calculated Bid (SCB), subject for post-qualification evaluation;

WHEREAS, on 18 December 2023, the TWG, after conducting the post-qualification evaluation of DBPSC, declared DBPSC as the Single Calculated and Responsive Bid (SCRB) having complied with and passed all documentary requirements for this procurement project.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to;

- a) *declare the bid of DBP Service Corporation (DBPSC) as the Single Calculated and Responsive Bid (SCRB); and*

b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement for the Provision of Outsourced Personnel Services for C.Y. 2024 with Solicitation No. PMO-02-2024 to DBP Services Corporation (DBPSC) at a contract price of Nine Million Nine Hundred Forty Thousand Four Hundred Eighty-Four Pesos and 4/100 (PhP9,940,484.04) upon approval of the funding source.
