Supplemental/Bid Bulletin No. 1

This Supplemental/Bid Bulletin No. 1 is being issued to clarify certain provisions in the Bidding Documents, as follows:

CLARIFICATION	RESPONSE
Do we need to submit the list of awarded contracts and copies of the contracts or only the list or matrix of awarded contracts?	During opening, we only need the list, however, during post-qualification, we need to see the supporting documents.
In Technical Specifications, do we need to put 'Comply' or is it required to attach the supporting documents for post-qualification?	Prospective Bidder shall indicate "Comply" in every item in Section VII Technical Specifications and submit documentary requirements as indicated in the Bid Data Sheet, Section 20.1. Bidders shall also sign the Conforme of Annex B, Schedule of Deployment and Requirements for each lot they intend to submit bid.
Do we need to submit a flash drive together with a folder that contains the password in google drive?	Submission of a flash drive is not needed, if you opt to submit in cloud or google drive. You just have to put the password in a sealed envelope and insert in the main envelope (One password each for the Technical Component and Financial Component, then these two pdf files must be enclosed in a main folder which is also password protected).
Is it okay if we choose to participate only in one lot? Say, we join in Lot 2 or Lot 3 only?	Yes, you are allowed to join.
In the computation of proposal, may we know what percentage is used in the computation for Philhealth?	We used 5%.
What is the minimum percentage allowed for agency fee?	Agency fee should not be lower than 20%.
Can we go below 20% of administrative overhead?	Minimum is 20%, you cannot go below 20%. The minimum is 20% up to 24% maximum.
