Supplemental/Bid Bulletin No. 1

This Supplemental/Bid Bulletin No. 1 is being issued to clarify, modify, and amend certain provisions in the Bidding Documents, as follows:

A. CLARIFICATIONS ON THE BIDDING DOCUMENTS

<p>Section 2.1 (a.iii) of Section II. Eligibility Documents requires a statement of the consultant specifying its nationality but Annex "D" of Section IV. Eligibility Forms there is no such statement. Is there a specific template or do we add the confirmation that we are a Filipino corporation?</p> <p>Who will sign the statement of nationality? The authorized representative or the corporate secretary?</p>	<p>Yes. Bidders shall submit a separate statement.</p> <p>The authorized representative shall sign (the document).</p>
<p>In Annex "C", it allows other proof of submission such as clearance issued by the procuring entity, certificate of completion issued by the procuring entity, and invoice/official receipts representing full payment of the completed project. However, the EDS requires the proof of completion to be submitted. May we request clarification on the inconsistency?</p> <p>Can we also submit the invoice or the OR representing full payment?</p>	<p>Bidders can submit the certificate of completion or acceptance of work.</p> <p>Yes.</p>

<p>May I confirm that the required documents to be submitted is as specified in Annex "C" and is not limited to the certificate of completion and acceptance only?</p>	<p>Yes.</p>
<p>There is a statement in Annex "D" that "on-call" personnel is allowed in the event that the team members are not sufficient or there are less than three (3) team members who cannot qualify. Is the contract between the company and the "on-call" personnel sufficient evidence?</p> <p>Is there a specific template with regards to the letter of commitment?</p>	<p>Prospective bidders may submit the contract or any other equivalent document signifying agreement of the key staff to be nominated to the project. <i>(please see amended Annex D)</i></p> <p>There is no specific template for the letter of commitment.</p>
<p>Do we have to submit the proof of authority of the authorized signatories such as Board Resolution or Secretary's Certificate?</p>	<p>Yes.</p>
<p>Most of the projects that we have are bound by NDAs and some of these projects are public equity transactions that have not been disclosed yet. When listing down these projects in the statement of ongoing projects, can it be on a blind basis, or the specifics are required?</p>	<p>The amount is essential for the computation of the prospective bidder's financial status. In case of confidential projects, prospective bidders can just put the amount of the contract, the duration, and date of contract. For the copies of the contracts which is required for post-qualification, the document may be redacted.</p>
<p>For the statement of key staff, there is a statement that says that the consultants are registered professionals authorized by the appropriate regulatory body to practice their profession. Can we get an example, for our reference, of which regulatory body are you thinking of for this requirement?</p>	<p>For licensed professionals such as engineers, the regulatory body is PRC. For consultants, the regulatory body as applicable based on the submitted CVs of the team members assigned to the project.</p>
