Bids and Awards Committee (PMO-BAC RA 9184)
Resolution No. 22-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Marketing Division I a request for the procurement of One (1) Year Pest Control Services - Mile Long Complex (MLC) through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Ninety-Eight Thousand Pesos (Php198,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-02 from February 7-13, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, three (3) suppliers were also invited to submit their quotation, namely:

- 1.) Power House Pest Control Services;
- 2.) Pinagpala Pest Control Services; and
- 3.) Mac J Pest Control Services

WHEREAS, on 13 February 2023, the Marketing Division I authorized canvasser, received five (5) quotation, namely:

- 1.) Mac J Pest Control Services – Php142,800.00;
- 2.) Infin8e Environmental Specialist Opc – Php188,800.00;
- 3.) Kapitan Pepe Pest Control – Php187,500.00;
- 4.) Power House Pest Control Services – Php107,770.08; and
- 5.) Greentech Pest Management, Inc – Php158,400.00.

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 1.) Mac J Pest Control Services – Compliant and responsive to all requirements;
- 2.) Infin8e Environmental Specialist Opc – Non-compliant to the minimum requirements;
- 3.) Kapitan Pepe Pest Control – Compliant and responsive to all requirements;
- 4.) Power House Pest Control Services – Compliant and responsive to all requirements; and
- 5.) Greentech Pest Management, Inc – Non-compliant to the minimum requirements.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of Power House Pest Control Services as the Lowest Calculated and Responsive Bid (LCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of One (1) Year Pest Control Services - Mile Long Complex (MLC) with Solicitation No. PMO-23-02 to Power House Pest Control at a contract price of One Hundred Seven Thousand Seven Hundred Seventy Pesos and 8/100 (Php107,770.08).*
