Resolution No. 17-2023

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Administrative Division a request for the procurement of Supply of Purified Drinking Water for PMO for CY 2023 through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (Php100,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-07 from February 1-6, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1) Newark Spring Water Corp.;
- 2) Aquasquare Water Trading;
- 3) Golden Tiger Water Refilling Station, and;
- 4) Global Quality Waters & Environment Technologies

WHEREAS, on February 06, 2023, the Admin authorized canvasser, received only one (1) quotation, from:

- 1) Newark Spring Water Corp. – Php77,760.00

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 1) Newark Spring Water Corp. – Compliant and responsive to all requirements

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of Newark Spring Water Corp. as the Single Calculated and Responsive Bid (LCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Supply of Purified Drinking Water for PMO for CY 2023 Solicitation No. PMO-23-07 to Newark Spring Water Corp. at a contract price of Seventy-Seven Thousand Seven Hundred Sixty Pesos (Php77,760.00).*
