DECLARING FAILURE OF BIDDING

WHEREAS, the PMO-BAC received from the Custodianship Service Division (CSD) a request for the procurement of Eleven (11) units of Smartphones to PMO for CY 2023 through Negotiated Procurement - Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Two Hundred Eighteen Thousand Pesos (Php 218,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-23-08 from February 16 to 21, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Annex H of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 ("The Government Procurement Reform Act"), In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1) Electroworld;
- 2) Silicon Valley (Glorietta Makati);
- 3) Silicon Valley (SM Manila); and
- 4) CCP Computer Technologies, Inc.

WHEREAS, the PMO-BAC received quotations from four (4) suppliers, namely:

- 1) Electroworld-Php193,989.00;
- 2) Silicon Valley (Glorietta)-Php193,480.00;
- 3) Silicon Valley (SM Manila)-Php208,989.00; and
- 4) CCP Computer Technologies, Inc.-Php202,990.00.

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), evaluated the submitted price quotations and found that:

- 1) Electroworld - non-responsive to the minimum requirements;
- 2) Silicon Valley (Glorietta) - non-responsive to the minimum requirements;
- 3) Silicon Valley (SM Manila) - non-responsive to the minimum requirement and;
- 4) CCP Computer Technologies, Inc. - non-responsive to the minimum requirement.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare failure of bidding pursuant to Section 53.1(c) of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA9184); and,*
- b) *recommend End-User representative to conduct a mandatory review and evaluation of the terms, conditions, and specifications of the procurement project, including its cost estimates, if necessary; and,*
- c) *submit approved procurement documents to the PMO-BAC for re-advertisement or posting.*
