**Resolution No. 27-2023**

**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT**

**WHEREAS**, the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of Janitorial/Housekeeping Supplies in MLC through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Four Hundred Sixty Thousand Seven Hundred Forty-Five Pesos (Php460,745.00);

**WHEREAS**, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-10 from February 15-21, 2023, in the Philippine Government Electronic Procurement System (PhilGEPs) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotation, namely:

- 1.) Maitre-D’ Industrial Sales Corporation;
- 2.) Prime Innov8 Manufacturing Co.;
- 3.) Kleanz Chemical Products Trading; and
- 4.) Zasan Marketing & Industrial Sales

**WHEREAS**, on 21 February 2023, the Marketing Division I authorized canvasser, received eight (8) quotation, namely:

- 1.) Maitre-D’ Industrial Sales Corporation;
- 2.) Beau Essence Health & Beauty Inc.;
- 3.) Prime Innov8 Manufacturing Co.;
- 4.) Ryrah Merchandising;
- 5.) Kleanz Chemical Products Trading;
- 6.) Zasan Marketing & Industrial Sales;
- 7.) RPD Chem Enterprises; and
- 8.) Ban Bee Commercial Co., Inc.


**WHEREAS**, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that:

- 6.) Zasan Marketing & Industrial Sales - Non-compliant to the minimum requirements;
- 7.) RPD Chem Enterprises - Compliant and responsive to all requirements ; and
- 8.) Ban Bee Commercial Co., Inc. - Compliant and responsive to all requirements

**NOW THEREFORE, WE**, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of Kleanz Chemical Products Trading as the Lowest Calculated and Responsive Bid (LCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Janitorial/Housekeeping Supplies in MLC with Solicitation No. PMO-23-10 to Kleanz Chemical Products Trading at a contract price of Two Hundred Ninety-Eight Thousand Two Hundred Pesos (Php298,200.00).*
