RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division a request for the procurement of Various ICT Software through Negotiated Procurement – Small Value Procurement, (Section 53.9) with an Approved Budget for the Contract (ABC) of Nine Hundred Thirty-Five Thousand Pesos (Php935,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-11, from February 10-14, 2023, in the Philippine Government Electronic Procurement System (PhilGEPs) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, three (3) suppliers were also invited to submit their quotation, namely:

- 1) IPSolutions Inc.;
- 2) Global Tiger Solutions; and,
- 3) WSI Philippines

WHEREAS, on February 14, 2023, the ITD’s authorized canvasser, received only one (1) quotation from IPSolutions Inc. in the amount of Nine Hundred Thirty-One Thousand Pesos (Php931,000.00); and,

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the submitted required documents and found that IPSolutions Inc. is compliant and responsive to the minimum requirements.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of IPSolutions Inc. as the Single Calculated and Responsive Bid (SCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Various ICT Software with Solicitation No. PMO-23-11 to IPSolutions Inc. at a contract price of Nine Hundred Thirty-One Thousand Pesos (Php931,000.00).*
