RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of Supply, Delivery and Installation of One (1) Unit 2.0 H.P. Inverter Split Type Airconditioning Unit for Mile Long Complex (MLC) through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Fifty-Two Thousand Pesos (Php52,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-34 from April 20-27, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”).

WHEREAS, on 27 April 2023, the Marketing Division I authorized canvasser, received a single proposal coming from Vistaaire Builders and Airconditioning Sales and Services, Inc.;


WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), found the proposal of Vistaaire Builders and Airconditioning Sales and Services, Inc. to have complied with the minimum requirements of the end-user unit and its quotation in the amount of Thirty-Nine Thousand Pesos (Php39,000.00) is within the ABC.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of Vistaaire Builders and Airconditioning Sales and Services, Inc. as the Single Calculated and Responsive Bid (SCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Supply, Delivery and Installation of One (1) Unit 2.0 H.P. Inverter Split Type Airconditioning Unit at MLC with Solicitation No. PMO-23-34 to Vistaaire Builders and Airconditioning Sales and Services, Inc. at a contract price of Thirty-Nine Thousand Pesos (Php39,000.00).*
