Resolution No. 79-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of Siphoning/De-Clogging of Septic Tanks at Mile Long Complex through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Eighty-Eight Thousand Pesos (Php88,000.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-40 from May 20-26, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act").

WHEREAS, on 26 May 2023, the Marketing Division I authorized canvasser, received a single proposal coming from JAA Plumbing Services;

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), conducted a thorough evaluation of the proposal received and found that JAA Plumbing Services has submitted the minimum requirements of the end-user unit and its quotation in the amount of Eighty-Five Thousand Five Hundred Pesos (Php85,500.00) is within the ABC;

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of JAA Plumbing Services as the Single Rated and Responsive Bid (SRRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Siphoning/De-Clogging of Septic Tanks at Mile Long Complex with Solicitation No. PMO-23-40 to JAA Plumbing Services at a contract price of Eighty-Five Thousand Five Hundred Pesos (Php85,500.00).*
