Resolution No. 88-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of 1-Unit Motor Pump 7.5 H.P. 230volts, 3-Phase; 1 Set Copper Float Valve with Ball 2"; and 1 Pc. G.I. Bushing Reducer 2 ½" X 2" at MLC through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Eighty-Eight Thousand Two Hundred Pesos (Php88,200.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-42 from June 9 - 13, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) ("The Government Procurement Reform Act").

WHEREAS, on 13 June 2023, the Marketing Division I authorized canvasser, received a single proposal coming from Eveson Enterprises;

WHEREAS, the PMO-BAC, through its Technical Working Group (TWG), found the proposal of Eveson Enterprises to have complied with the minimum requirements of the end-user unit and its quotation in the amount of Eighty-Two Thousand Four Hundred Thirty Pesos (Php82,430.00) is within the ABC.

NOW THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) *declare the price quotation of Eveson Enterprises as the Single Calculated and Responsive Bid (SCRB); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of 1-Unit Motor Pump 7.5 H.P. 230volts, 3-Phase; 1 Set Copper Float Valve with Ball 2"; and 1 Pc. G.I. Bushing Reducer 2 ½" X 2" at MLC with Solicitation No. PMO-23-42 to Eveson Enterprises at a contract price of Eighty-Two Thousand Four Hundred Thirty Pesos (Php82,430.00).*
