## RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Marketing Division I, a request for the procurement of 1-Unit Motor Pump 7.5 H.P. 230volts, 3-Phase; 1 Set Copper Float Valve with Ball 2"; and 1 Pc. G.I. Bushing Reducer 2 ½" X 2" at MLC through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Eighty-Eight Thousand Two Hundred Pesos (Php88,200.00);

**WHEREAS**, the PMO-BAC, through its Technical Working Group (TWG), found the proposal of Eveson Enterprises to have complied with the minimum requirements of the end-user unit and its quotation in the amount of Eighty-Two Thousand Four Hundred Thirty Pesos (Php82,430.00) is within the ABC.

**NOW THEREFORE, WE**, the Members of the PMO-BAC, hereby **RESOLVE** as it is **RESOLVED**, to:

- a) declare the price quotation of Eveson Enterprises as the Single Calculated and Responsive Bid (SCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of 1-Unit Motor Pump 7.5 H.P. 230volts, 3-Phase; 1 Set Copper Float Valve with Ball 2"; and 1 Pc. G.I. Bushing Reducer 2 ½" X 2" at MLC with Solicitation No. PMO-23-42 to Eveson Enterprises at a contract price of Eighty-Two Thousand Four Hundred Thirty Pesos (Php82,430.00).
