Resolution No. 125-2023**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Administrative Division a Request for Procurement of Various Electrical/Plumbing Supplies through Negotiated Procurement – Small Value Procurement (Sec. 53.9) with an Approved Budget for the Contract (ABC) of Sixty-Five Thousand Seven Hundred Eighty Pesos (Php65,780.00);

WHEREAS, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-56 from September 14 to 21, 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotations, namely:

- 1.) Ace Greenbelt;
- 2.) Champion Hardware;
- 3.) Innovalite Philippines; and
- 4.) Boston Builders Center

WHEREAS, the PMO BAC received eight (8) quotations and the Technical Working Group (TWG) conducted a thorough evaluation of the quotations received, the results are as follows:

- a) declare the price quotation of **Innovalite Inc.** as the Lowest Calculated and Responsive Bid (LCRB); and,
- b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of **Various Electrical/Plumbing Supplies** with Solicitation No. PMO-23-56 to **Innovalite Inc.** at a contract price of Fifty-One Thousand One Hundred Fifty Pesos (Php51,150.00), inclusive of all applicable government taxes.
