**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT**

**WHEREAS**, the PMO-BAC, through its Secretariat, received from the Administrative Division a Request for Procurement of Various Janitorial Supplies through Negotiated Procurement – Small Value Procurement (Sec. 53.9) with an Approved Budget for the Contract (ABC) of Seventy-Seven Thousand One Hundred Fifty Pesos (PhP77,150.00);

**WHEREAS**, the PMO-BAC posted the Request for Quotation (RFQ) with Solicitation No. PMO-23-57 from 14-21 September 2023, in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO Website, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, three (3) suppliers were also invited to submit their quotations, namely:

- 1.) Maitre-D Industrial Sales Corporation;
- 2.) Blue Mountain Safety and Industrial Products; and
- 3.) Beau Essence Health and Beauty, Inc.

**WHEREAS**, the PMO BAC received five (5) quotations and the Technical Working Group (TWG) conducted a thorough evaluation of the quotations received, the results are as follows:
