**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT**

**WHEREAS**, the PMO-BAC, through its Secretariat, received from the Information Technology Division (ITD), a Request for Procurement of Desktop Computers (12 units) through Negotiated Procurement – Small Value Procurement (Sec.53.9) with an Approved Budget for the Contract (ABC) of Five Hundred Forty Thousand Pesos (Php540,000.00);

**WHEREAS**, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-14 from February 09,2024 in the Philippine Government Electronic Procurement System (PhilGEPs) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, Seven (7) suppliers were also invited to submit their quotations, namely:

- 3.) BayanPc Technologies, Inc;
- 4.) Columbia Technology, Inc;

**WHEREAS**, after the deadline for submission and receipt of quotation on 16 February 2024, the PMO BAC received three (3) quotations and the Technical Working Group (TWG) conducted a thorough evaluation of the quotations received, the results are as follows:

b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the procurement of Desktop Computer (12 units) with Solicitation No. PMO-24-14 to **Xitrix Computer Corporation** at a contract price of **Five Hundred Four Thousand Pesos (Php504,000.00)**, inclusive of all applicable government taxes.
