RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division (ITD), a Request for Procurement of Various ICT Software Subscriptions through Negotiated Procurement – Small Value Procurement (Sec.53.9) with an Approved Budget for the Contract (ABC) of Eight Hundred Seventy-Five Thousand Pesos (Php875,000.00);

WHEREAS, on 6 March 2024, three (3) Suppliers were invited to submit their quotations and documentary requirements for the Request for Quotation with Solicitation No. PMO-24-19 until 11 March 2024, namely:

- 1.) Global Tiger Solutions;
- 2.) IPSolutions, Inc.; and,
- 3.) Wordtext Systems, Inc.

WHEREAS, after the deadline for submission and receipt of quotation on 11 March 2024, the PMO BAC received two (2) quotations and the Technical Working Group (TWG) conducted a thorough evaluation of the quotations received, the results are as follows:
