**RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT**

**WHEREAS**, the PMO-BAC received from the Administrative Division a request for the Procurement of Electrical Supplies through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Eighty Thousand Pesos (Php80,000.00);

**WHEREAS**, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-29 from May 04 to 10, 2024 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotations, namely:

- 1) Luzon Sales Co. Inc;
- 2) Bostonm Builders Center;
- 3) Reliqua Trading; and,
- 4) Remitechs Electrical.

**WHEREAS**, on 10 May 2024, after the deadline for submission and receipt of quotations, the PMO-BAC received three (3) quotations and the Technical Working Group (TWG), conducted a thorough evaluation of the quotations received, the results are as follows:

- a) *declare the price quotation of **Champion Hardware Co., Inc.** as the Lowest Calculated and Responsive Quotation (LCRQ); and,*

b) recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the Procurement of Electrical Supplies with Solicitation No. PMO-24-29 to **Champion Hardware Co., Inc.** at a contract price of **Seventy-Five Thousand Five Hundred Seventy Four Pesos (Php75,574.00)**, inclusive of all government taxes.
