Resolution No. 070-2024**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Administrative Division a Request for Procurement of Janitorial Supplies through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Two Hundred Seventy-Four Thousand Pesos (Php274,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-31 from May 09 to 14, 2024 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, four (4) suppliers were also invited to submit their quotations, namely:

- 1) Maitre-D’ Industrial Sales Corp.;
- 2) Kleanz Chemical Products Trading;
- 3) Champion Hardware; and,
- 4) Boston Builders Center.

WHEREAS, on 14 May 2024, after the deadline for submission and receipt of quotations, the PMO-BAC received eight (8) quotations and the Technical Working Group (TWG), conducted a thorough evaluation of the quotations received, the results are as follows:

Doctor, to award the Procurement of Janitorial Supplies with Solicitation No. PMO-24-31 to **Maitre-D' Industrial Sales Corporation** at a contract price of **Two Hundred Thirty Six Thousand Thirty Pesos (PhP236,030.00)**, inclusive of all government taxes.


