Resolution No. 081-2024**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Administrative Division a Request for Procurement of Airconditioning Units through Negotiated Procurement – Small Value Procurement (Section 53.9) with an Approved Budget for the Contract (ABC) of Three Hundred Sixty-Five Thousand Pesos (PhP365,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-38 from June 07 to 13, 2024 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, three (3) suppliers were also invited to submit their quotations, namely:

- 1) Perry A Trading Corp.;
- 2) Innovalite Inc.; and,
- 3) Ban Bee Commercial Company Inc.

WHEREAS, on 13 June 2024, after the deadline for submission and receipt of quotations, the PMO-BAC received two (2) quotations and the Technical Working Group (TWG), conducted a thorough evaluation of the quotations received, the results are as follows:

- a) *declare the price quotation of **Perry A Trading Corp.** as the Lowest Calculated and Responsive Quotation (LCRQ); and,*
- b) *recommend for approval by the Chief Privatization Officer and Head of the Procuring Entity, Atty. Maan Vanessa L. Doctor, to award the Procurement of Airconditioning Units with Solicitation No. PMO-24-38 to **Perry A Trading Corp.** at a contract price of **Three Hundred Twenty-***

**Seven Thousand Seven Hundred Sixty Pesos (Php327,760.00),
inclusive of all government taxes.**
