Resolution No. 088-2024**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division, a Request for procurement of Internet Service Provider through Negotiated Procurement – Small Value Procurement (Sec. 53.9) with an Approved Budget for the Contract (ABC) of Eight Hundred Forty Thousand Pesos (Php840,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-41 from June 20 to 24, 2024 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, three (3) suppliers were also invited to submit their quotations, namely:

- 1.) Eastern Telecommunications Philippines, Inc.;
- 2.) Globe Telecom, Inc.; and
- 3.) PLDT, Inc.

WHEREAS, on 24 June 2024, before the deadline for submission and receipt of quotations, the PMO-BAC received only one (1) quotation and the Technical Working Group (TWG), conducted a thorough evaluation of the quotations received, the results are as follows:

Doctor, to award the procurement of Internet Service Provider with Solicitation No. PMO-24-41 to **Eastern Telecommunications Philippines, Inc.** at a contract price of **Seven Hundred Forty-Four Thousand Pesos (PhP744,000.00)**, inclusive of all applicable government taxes.*
