Resolution No.087-2024**

RECOMMENDING APPROVAL FOR THE AWARD OF CONTRACT

WHEREAS, the PMO-BAC, through its Secretariat, received from the Information Technology Division (ITD), a Request for Procurement of Various ICT Equipment through Negotiated Procurement – Small Value Procurement (Sec.53.9) with an Approved Budget for the Contract (ABC) of Two Hundred Seventy-Five Thousand Pesos (Php275,000.00);

WHEREAS, the PMO-BAC posted a Request for Quotation (RFQ) with Solicitation No. PMO-24-43 from June 22 to 25, 2024 in the Philippine Government Electronic Procurement System (PhilGEPS) and PMO websites, as well as in conspicuous places in its premises, in accordance with Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA 9184) (“The Government Procurement Reform Act”). In addition, six (6) Suppliers were also invited to submit their quotations and documentary requirements until 5:00 P.M. of 25 June 2024, namely:

- 1.) Quadstar Systems OPC;
- 2.) BayanPC Technologies, Inc.;
- 3.) Columbia Technologies, Inc.;
- 4.) Sagittarius Hardware Trading;
- 5.) IPSolutions Inc.; and,
- 6.) Infoworx, Inc.

WHEREAS, before the deadline for submission and receipt of quotation on 25 June 2024, the PMO BAC received only one (1) quotation from Quadstar Systems OPC. Also, BayanPC Technologies, Inc., submitted their quotation through email beyond the deadline for submission and receipt of quotation on 25 June 2024 at 5:10 P.M.;

WHEREAS, the Technical Working Group (TWG) conducted a thorough evaluation of the quotation received from Quadstar Systems OPC and the results are as follows:


NOW, THEREFORE, WE, the Members of the PMO-BAC, hereby **RESOLVE** as it is hereby **RESOLVED** to:
